## **Resolutions/Bylaws Committee Update**

The Resolutions/Bylaws Committee has been hard at work over the past several months reviewing proposed resolutions for consideration by regular members at this year's annual conference and business meeting. The Committee is chaired by Eric Griffin, Ohio Board of Pharmacy, Vice President of NASCSA and consists of members Terri Witkowski-Iowa Board of Pharmacy/PMP, Larry Houck – Hyman, Phelps & McNamara, Stephanie Mueller – MS Board of Pharmacy and Shannon Tonn – Minnesota Board of Pharmacy. To date there are no proposed changes to the bylaws. However the committee has put forth a number of Resolutions for consideration:

## Joint Economic Committee Releases Cost of Opioid Crisis Report

The Joint Economic Committee of Congress recently released a new [analysis](#) of the cost of the ongoing opioid epidemic. The analysis finds that the opioid crisis cost the U.S. nearly \$1.5 trillion in 2020, a nearly 50% increase of \$487 billion over 2019. This cost includes expenses for health care, criminal justice, lost productivity, lower quality of life, and the projected value of lives lost.

The analysis recommended several policy solutions to address the opioid epidemic, including addressing the barriers to healthcare, increasing opioid death data collection, and prioritizing medical treatment over incarceration. ## DEA Announces Results of Enforcement Surge to Reduce the Fentanyl Supply Across the US

More than 10.2 million fentanyl pills and about 980 pounds of fentanyl powder were confiscated by the Drug Enforcement Administration (DEA) between May 23, 2022, and September 8, 2022, as part of the [One Pill Can Kill](#) campaign. The amount of fentanyl seized during this five-month operation is equal to more than 36 million lethal doses removed from the illegal drug supply. In addition to illicit pills, DEA seized 338 weapons. Out of the 390 cases that were tied to this operation, 51 cases were linked to overdose poisonings, and 129 were tied to social media platforms.

Drug Enforcement Administration (DEA) announced that the next [National Prescription Drug Take Back Day](#) will take place on October 29, 2022, from 10 AM to 2 PM. Individuals can turn in their unneeded or expired medications at a collection site within their city.
